Vendor Pricing:

Early registration price is \$800 for a basic 10x10 booth and \$900 for a premium booth. Extra 10x10 basic booth price is \$700 and a premium 10x10 booth is \$800. Early registration pricing ends on July 1st, 2024. After July 1st the price for a basic 10x10 booth is \$900 and a premium booth is \$1050. Extra 10x10 basic booth is \$800 and a premium booth is \$900.

Please note that registration for the banquet opens in the fall of 2024 and anyone interested in attending the banquets must register online through our website. These rates do not include banquet tickets.

Vendor Application & Contract Agreement

Exhibit booths are open to commercial firms, corporations or small businesses who regularly provide products or services related to the education, conservation, research and recreational activities of the Wild Sheep Society of BC (WSSBC). Display space is also assigned to non-commercial provincial organizations of similar purposes.

Installation and any fees associated with the set-up of exhibit booth is the responsibility of the Exhibitor. WSSBC personnel will not assist in any of the set up or dismantling of your exhibit or display. The WSSBC reserves the right to make changes in booth assignments through to Sunday, February, 23rd, 2025 to ensure an even flow of attendee traffic or to maintain character of the show. Non-Exhibitor solicitation is strictly prohibited.

Firearms, ammunition, and knives are permitted on-site during the Trade Show with Special Conditions: All Exhibitors displaying firearms and ammunition during the show will be required to follow Canadian Government Laws regarding the display of firearms including the following: Firearms must be unloaded and either: made inoperable with a secure locking device (such as a trigger lock) or must be locked in a sturdy container which cannot be easily broken into. Overnight firearms are to be secured in a locked sturdy container or cabinet that cannot be easily broken into. Exhibitors must have all pertinent permits available onsite.

All exhibitors must strictly follow all the rules in accordance with the Canadian Firearms Act, and while displaying firearms during the show be required to strictly follow all Canadian Firearms Government laws regarding the display of firearms. All entities (individuals and businesses) who will be possessing firearms must hold a valid firearms license. For individuals, they must have a valid Possession and Acquisition License (PAL). A business will have a Business Firearms License (BFL) and all their employees who would handle firearms must also hold a valid PAL. Breech loaded firearms displayed must be deactivated by removal of the firing pin or otherwise altered or locked so they may not be fired.

Exhibitors shall not injure or deface walls or floors of the building, or equipment of the booths. If such damage occurs, the exhibitor will be liable. Exhibitors must comply with all Federal, Provincial, and local fire, police, healthy or public safety laws, regulations or ordinances which are or maybe applicable to the exhibit covered by this agreement. No outside alcohol is permitted in the Penticton Trade & Convention Centre facility at any time.

These rules and regulations have been formulated in accordance with public safety rules and in the best interest of the exhibitors, WSSBC management and its members and visitor. Exhibitors expressly accept and agree to abide by these regulations and any and all matters, whether or not specifically covered in the regulations are subject to the sole discretion and final decision of WSSBC. Exhibitor agrees to abide by the determinations of WSSBC.

By signing the contract, the exhibitor agrees to indemnify and save harmless the WSSBC and subcontractors, officers and directors from any and all liability of every nature which may be asserted or event of any kind whatsoever which may arise from or may in anyway be related to exhibitors attendance at the Penticton Trade and Convention Centre described herein.

Exhibitor booths will be in Ballroom Two at the Penticton Trade and Convention Centre. The setup time is between 1:00pm - 10:00pm on Thursday, February 20th, 2025. The tear down period will be from 8:00am - 12:00pm on Sunday, February 23rd, 2025. No early tear down is permitted while show is in progress. All exhibits must be removed by 12:00pm on Sunday, February 23rd, 2025.

Exhibitors acknowledge that they have read, understand, and will abide by the terms and conditions of this agreement. Exhibitor understands a space is reserved only with full payment or allotted donation level and delivery of this contract and is subject to booth availability.

Exhibitor Insurance: Each Exhibitor must provide the WSSBC with a certificate of liability insurance for \$2,000,000 to Kris Wrathall at OvisSlam@outlook.com. This certificate must be received no later than January 31st, 2025. Insurance needs to state the name of the event, along with the date. Insurance specifics: \$2M liability insurance. Mountain Hunting Expo and Salute to Conservation February 20-23, 2025.
